- Foster Youth Programming Priority of Service Policy
  - Foster youth emphasis causing us to look at adjusting policy for WIOA youth if in school and foster or kinship care (kinship – foster placed with family member after guardianship revoked)
  - 16+ range
  - Will discuss potential policy change with full Council in December if supportive, One-Stop Committee would need to initiate in January
  - Comments
    - Great need, graduation rate is currently 50%
    - Seeing correlation to this with VR
    - Goal to provide more specific outreach to this group especially to Launch, guidance and advising
    - Anticipate policy change will be simple
    - Currently working on outreach piece
- Vocational Rehabilitation Update on Order of Selection MiKayla Monaghan
  - Still in process, no anticipation for end
  - Homepage has statement about categories, will be updated when appropriate
  - Category placement can be appealed
  - Very intentional in all communications, minimal event participation at present due to order of selection, can participate in those that allow us to serve those that are currently in the process
  - Pre-ETS program has changed significantly, refining service, working through stages rather than just jumping in, continually communicating with education partners
  - Need is communication and collaboration
    - Partners are asking how they can support, positive at present
  - Natcast Grant Update
    - Related to CHIPS Act Natcast became the Workforce Development Center of Excellence for Semiconductor Industry
    - Micron is CHIPS act recipient
    - WDC put in \$1.2M proposal for Idaho, to augment the expansion of "semiconductor/automated manufacturing" training programs with support services
    - Currently the programs project a 70% graduation rate, let's increase by removing barriers like childcare, housing, transportation, etc. Grant will provide up to \$2,500 in support for participants
    - Idaho was 1 of 7 awarded
    - Idaho Technical Council will be the fiscal agent, directly doing case management

  - No comprehensive model, great individual methods
  - $\circ$   $\;$  Desire to be proactive on what we can do across the system
  - Rhode Island simplified their approach to "Is it improving the lives of the participants"
  - $\circ$   $\;$  What does success look like, perhaps move towards tackling this as a system
  - Kristyn new data sharing agreement coming for better picture of co-enrollment
