Review of WIOA In-School Youth Eligibility and Priority of Service Policy document:

- Updated policy last year, combined two policies into one
- IDOL youth service provider exploring how to better serve foster/kinship care and youth with disabilities
- Updates review
  - General cleanup of language, reference to CFR
  - Adding In-School Youth (ISY) Section
    - Prior to WIOA did serve ISY
    - Switched to out of school
    - Federal maximum spend is 25% of budget
    - Realized benefits in connecting with ISY for future success
    - Current Department of Health Welfare focus on Foster and Kinship
    - VR has robust program for ISY, due to Order of Selection we felt we could help
    - Intent to focus on these priority groups along with
      - Pregnant, justice involved, disabilities
  - o ISY definition defined
  - Foster and Kinship included and clarified

- 75% of budget to Out-of-School Youth (OSY)
- Can request waiver to change spend to 50% for each program
- Clarifying free and reduced lunch
- Funds are generally \$2.3M, set-asides reduce the number, formula for allocations are population driven
- VR has data showing that providing workforce experience prior to graduation increases the rate of participation in workforce after graduation
- o Law requires 25% spend on work experience activities
- o ISY is work experience only, no payment allowed for training
