The regular meeting of the State Board of Examiners was called to order pursuant to Idaho Code §67-2002 and by the order of the chair at 8:56 a.m. The following board members were present: Governor Brad Little, Secretary of State Phil McGrane, and Deputy Chief of Staff Brian Benjamin, as assistant secretary of the Board of Examiners. State Controller Brandon Woolf was absent and Attorney General Raul Labrador arrived during the presentation of regular agenda item #6.

Also present was Stephanie Bonney (Moore Smith Buxton & Turcke, Chartered).

Brian Benjamin introduced and reviewed each of the consent agenda items. Secretary of State Phil McGrane moved to approve the consent agenda. Governor Brad Little seconded the motion. The motion passed by unanimous voice vote.

Brian Benjamin then yielded the time to Stephanie Bonney to review regular agenda item #6. Ms. Bonney gave a brief overview of the request on behalf of the State Treasurer's Office, asking for authority in case they need to issue a tax anticipation note. She explained the tax anticipation is used in instances where in the first half of the year there is greater expenditures and in the second half of the year, greater revenues. Ms. Bonney said it's not that the state needs to borrow money, but this is to match up revenue and expenditures. The State Treasurer's Office is not able to determine whether it would be in the best financial interest of the state to issue the notes until late April when there is a better idea of revenues. Ms. Bonney also said the State Treasurers Office has not had to issue a note since 2021 and although the amount of the note reflects the authorization that's allowed by law, that is further limited by IRS regulations and generally the notes never exceed 500 million.

Secretary of State Phil McGrane moved to approved agenda item #6. Governor Little seconded the motion. During the presentation of regular agenda item #6, Attorney General Raul Labrador arrived at the meeting and participated in the vote. The motion passed by unanimous voice vote. The members present signed the accompanying proclamation.

Brian Benjamin then reviewed the informational agenda items.

Secretary of State Phil McGrane moved to adjourn the meeting. Governor Brad Little seconded the motion.

There being no further business before the board and on motion duly made and seconded, THE MEETING OF THE STATE BOARD OF EXAMINERS WAS ADJOURNED at 8:59 a.m.
