9:20 am (20 min)	Governor's Priorities – Jared Larsen	Governor's Broad priorities: Education: There is a nexus between the commission/justice system and education. The legislature allocated \$380M ongoing to education. The legislature this session will determine how that will be spent. The Governor's recommendation for spending: Teacher pay, school safety, and property tax relief. He didn't give specifics on tax relief, but we know when we address infrastructure needs it is tax relief.	
		The governor requested a salary study and we found that we were underfunding law enforcement. He is recommending an increase for state law enforcement. The state also fell short in IT and nursing. Ultimately the legislature gets to	
		decide what is done. Operation Esto Perpetua: There is a fentanyl taskforce, the budget request includes funds for a team to work on this issue. ISP only has one mobile scene trailer. We are looking to get two more. It will help with response times. There

	is also a request for more funds for drug testing. We also need more funds for training.	
	The Governor is looking to add \$1.1M for stabilization for POST. There have been whole classes of academies that have been canceled.	
	Pre-plea diversion program: This program would be an enhancement to our drug courts. This will be run through the courts. Future presentation by Sara Omundson?	
	The Governor has requested, and the state has appropriated \$6M safe teen assessment centers for youth to help them avoid the juvenile correction system. This will help change the narrative of "get your kid into the system so they get the help they need". There are 8 centers around the state (one in each district, two in district 5) There is \$4.1M round two funding for more assessment centers and for existing centers. These funds have been matched with people in the community. This is a great thing for our state. The ideas is to start identifying at risk youth sooner before they get into the system. How many children will be able to serve? In the first two days without any advertising the Burley saw 6 youth. We are expecting pretty good numbers, especially once we advertise.	
	IDJC has seen a decrease in the deepest of services. Lewiston doesn't have very many youths in their facility and has great space to help with other services. The hope is to help service IDJC residents on the secure side and citizens on the non-secure side. It will be a great multi-use facility. We are starting in Lewiston and if it goes well, we will look at the other parts of the state. This is a great way to be good stewards of the public's money. This will keep families together for integrated treatment.	
	Some of the dangerously mentally ill population is being housed in our corrections facilities even though they have never committed a crime. There will be a new facility. Two populations will be served: those in a civil commitment process and those who need competency restoration. Those needing competency restoration need to be placed in a facility until they can assist in their case.

		Sometimes these individuals are deemed seriously mentally ill, and they are sent to the maximum-security prison. These facilities are not designed to help this population. It will be a 16-bed facility. The state is being proactive to address the housing for this population. Where are the female population housed? They are going to the mental unit in Pocatello.	
9:40 am (20 min)	MMIP Issues – Heather Cunningham and Bernie LaSarte, co-chairs MMIP subcommittee	What is MMIP? Indigenous persons experience disproportionately high rates of violence, and, relatedly, are reported missing or are murdered at higher rates than non-Indigenous persons.	
		This is not unique to Idaho. Indigenous communities experience higher rates of violence. In 2020 the House passed HCR33 which designated May 5 <sup>th</sup> awareness for MMIP day. There was a report done and it shows that indigenous persons are 10x higher than the national average for being murdered. Report recommendations: standardize MMIP case response, standardize data collection, sharing, and accuracy, increase agency collaboration, and enhance the capacity of the Missing Persons Clearinghouse.	
		It is unique because we have county, tribal, state, and our surrounding states. This creates complicated jurisdiction issues. Mission statement: Research and identify current systems and resources dedicated to addressing and combating significant and unacceptable rates of missing & murdered Indigenous persons in the State of Idaho, and among members of Idaho tribes in neighboring states. Identify and seek to implement evidence-based strategies and community-centered practices not currently utilized in the state. Evaluate Idaho's statutory scheme related to MMIP and, if necessary, propose legislation to address and support efforts to curb the current trend.

	Membership: There are tribal members, tribal law enforcement, other law enforcement, federal partners, and other statewide partners. There is a need for state legislators, judges, medical examiner/coroner, and county/tribal prosecutors. This is a gap the committee is looking for help filling.	
	Ongoing updates to the Clearinghouse: adding data fields other national agencies collect, working to develop a switch to allow other clearinghouses to connect to ours, adding data fields specific to MMIP such as tribal affiliation, enrollment, MMIP "flag", and updating servers to comply with EMPA (endangered missing person alert).	
	Thanks to the legislature there is the new alert system. There have been 11 alerts since that implementation. None have been indigenous yet, but we are hopful for this new system.	
	Ongoing challenges: Points of contact on reservation and county/city law enforcement. There is a sense of discomfort sharing tribal court criminal history with non-tribal law enforcement. There is also confusion around who has legal authority over the victim and alleged offender. There are more challenges as well.	
	When a non-tribal person who is harming a tribal person on the reservation, non- tribal law enforcement can now act. Oklahoma v. Castro-Huerta	
	Jurisdictional challenges: There is confusion on who has responsibility of housing the offender. It is hard to balance culture and family dynamics and there are community activism components. All of this takes trust and trust takes time.	
	POST certification: Tribal officers go to POST and also go to another training; however, if they go to work on a reservation, they don't keep their POST certification. We are looking for cross deputization.

		MOU – MOUs would be a great tool between tribes and surrounding law enforcement. This would help with some of the challenges listed above. These MOUs will help keep policies and practices in place when there is turnover on either side. There is no "one size fits all" MOU.	
		North Idaho does really well with their relationships and agreements. We are looking to them for some best practices.	
		Other states and MMIP: Washington formalized a task force. They have over 100 recommendations. Key recommendations: all LE should expand their collaboration and coordination with federal, state, county, local, and tribal social and health services, require all LE agencies to use the systems (we need this in Idaho). The legislature should establish and fully fund a cold case investigation unit. Lastly, all law enforcement should use the national missing and unidentied persons system.	
		Next work: Membership gaps: the sub-committee needs legislators, judges, coroner, and prosecutors.	
		The sub-committee wants to meet with each tribe. This will allow for the committee to learn about the tribes and so will understand more. You want to be respectful, but it is hard if you don't know the culture.	
		Designate MMIP as a crisis in Idaho. One of the worse things to do to victims is having a very hard system to navigate.	
		Need to explore more funding options.

		There are two policy issues that the legislature needs to be aware of. The subcommittee wrote and approved a letter. The courts each year look at statutes for defects. In section 18-1508A there appears to be an issue and the committee can't decide whether or not is was on purpose. There is a recommendation to make a change, so the cross reference is in place. The second issue is in regard to a bill that did not pass last year (HB625). The sub-committee decided that there is current language that covers these acts. Recommendation that the current conduct is covered by law.	
		Denton Darington made a motion to support sending the sub-committee to the legislature for clarification on why new legislation is not needed, Jared Larsen seconded. Motion carried.
