Reach out specifically to the tribe for educational opportunities. Ryan suggested a session during IJJA on how to work with various tribes. Suggestion was made for a panel to help educate how to work effectively with tribes and create better/meaningful collaboration. 9.	Tribal Updates	<ul> <li>Nez Perce: Drug use and suicide rates still high and of concern; dependency cases increased. Fentanyl continues to be an issue with newborns and addicted parents. New teen home has opened, open to up to 12 teens for teens that need to be removed from drug addicted parents/homes. Office of Legal Counsel has hired a new person, Janette. Natasha Anderson is new judge – previous prosecutor. Ryan has been pushing for more youth activities; new teen nights and hopeful for new teen nights in Kamiah.</li> <li>Coeur D'Alene: Social services very understaffed; foster homes limited but applications taking very long to process/license. Numbers for justice involved youth continue to be low. Adult referrals to probation have increased since January 2023. Trends continue to be influenced by drug use, Fentanyl in particular; overdoses continue to be an issue. Drug trafficking has been a concern. A lot of the new cases involves young adults. Youth activities with the Core Center continues to do a lot of great work, prevention efforts seem to be successful.</li> <li>Kootenai: Not a lot of changes. New social worker has been hired which can act as a liaison for the state that can help connect services prior to a report is made.</li> </ul>	Members
