*FY2023 Project Modification Requests

- Baby Bee American Falls
 - Budget Modification Requests
 - \$360,000 was awarded initially with \$350,000 for purchase of their building.
 - Building purchase will be \$300,000 and they would like to shift the \$50,000 not being used for purchase into building repairs.

Motion by Ms. Lori McCann to recommend moving forward with the requested modifications to the budget. Second by Ms. Anna Almerico. Motion carried.

- Cookies N Milk
 - Budget Modifications
 - Contractor Delays, repairs forthcoming possibly spring

A proud partner of the americanjobcenter network

- They would like to shift funding dedicated to blacktop and parking to personnel.
- Contract up at the end of the month, can extend and ask that funds to go into the blacktop project.
 - Fully operational and have met the contracted number of new Child Care seats.
 - Project is successful without adding the blacktop, and grantee could close out the grant if funding can shift to an eligible line item.

Motion by Ms. Emily Allen to recommend moving forward with the requested modifications to the budget. Second by Ms. Renee Bade. Motion carried.

- Chita's Preschool
 - Budget Modifications
 - Expended full facility budget, costs exceeded anticipated costs.
 - Need for van with expansion of seats.
 - Shift all remaining items except personnel to facility budget. Moving most items into regular budget for facility.
 - Will need extension, fully staffed with call in availability.

Motion by Mr. Martin Balben. to recommend moving forward with the requested modifications to the budget. Second by Ms. Lori McCann. Motion carried.

Discussion:

Changes to the original budget scope for new items must come to the committee for approval.

Small Provider application parameters and timeline discussion

- Parameters needed around small providers (serving 12 or fewer) that qualify for \$4M Small Provider set aside.
- Guidance:
 - Eligibility
 - Set aside and extension for apps, letter of intent.
 - Wants to double to 24 do they remain "small"?
 - Legislative discussion brought about the "small" provider aligned to Health & Welfare definition.
 - Suggestion:
 - New serving 12 or fewer.
 - Current 12 or fewer planning to expand.
 - Cap at 24
 - Serving ages 0-13, and/or serving children with disabilities who are 14-18
 - Automatically starting at zero does not qualify for "small."
 - Medium starts at 39.
 - Policy states up front funding will be considered for those serving 24 or fewer.
 - Business plan feasibility
 - No cap leads to ambiguity for applicant guidance and weakens the intent to serve true small providers.

- Potentially use any rollover for larger providers not funded from general pool of applications.
- Decision: Small provider definition "New provider serving 12 or fewer, or a current small provider expanding to 24 or fewer."
 - LOI and set aside eligibility.
 - Proposing Feb. 15th due date for small provider applications may be pushed to Mar. 1st if needed.
