Most of his case load is heavy drug and alcohol abuse. He gathers information for the juvenile's social histories. Having this education will assist him to give more insight to provide the best supervision for his cases.</p> <p>Kalyssa Kempthorn is with Canyon County JPO. She also gathers information to produce the youth's social histories and recommendations. There is motivational interviewing workshop that is part of the seminar and it will help with her interview skills with juveniles. There is also a neurobiology workshop to help educated her for juveniles with prolonged drug use.</p> <p>Sydney Brown has been employed with Canyon County JPO for two years. She is part of the Diversion Program. All the trends have changed in just two years. This seminar will be helpful to look for providing better services to what is happening now. She stated it will also be helpful with providing information to parents.</p> <p>Angie Martinez has been employed with Canyon County JPO for 24 yrs. She was provided funding for ICADD conference in 2018. Out of all of the training conferences she likes this one the most. She came away with a lot of knowledge from this conference last time she attended in 2018.</p>

		<p>The conference helped her to understand what recommendations need to be made for the juveniles. She is the first to see the juveniles in court upon sentencing. There will be webinars about fentanyl and she is wanting to see the trends of fentanyl and how to become proactive in detecting drug use of that specific drug. Would like to attend the neurobiology workshop to be educated in the long-term effects this type of drug use has on the brain. She stated it will also be helpful to get the refreshers from workshops she may have already viewed.</p> <p>Colin Welch is employed with Canyon County JPO and is a part of the diversion program. Knowing the information from this conference will educate him more on what will help with recidivism. Education from the conference will also help with current trends with drug and alcohol use. Has been with Canyon County JPO for 1 yr. 3 months. He was taught at IDADC was educational more about mushrooms making a comeback.</p> <p>Linda stated a large percentage in diversion are drug use, and has heard from her JPO's how difficult it is to help youth maintain sobriety.</p> <p>Group discussion about the challenges of youth getting easily accessible drugs. Also, about mental health issues among youth, and providers that are accessible for the JPO's to refer youth to.</p>

Right now, JPO's are using Paula, Hakim, Darryl for mentors. New clinician has started. Clinician has not been assigned what tasks they will do yet. They have been observing the JPO's. Linda stated there is many new staff and a lot of training has been occurring. She stated there are open job opportunities at Canyon County JPO. Many of the youth that are coming to probation have mental health, and some providers have been stating to get a youth charged in order for them to receive services which is concerning to JPO's. Discussed with Savannah on victim therapy availability options for SO victims.</p> <p>Tara working with the Marsing School Dist. For a sub grant with Boys & Girls' club associated with anti-substance use. They currently have a sub grant with group out of McCall that oversees work in New Meadows. Working with Bound BSU life skill for youth to address substance abuse. Shannon will send out an email about the MOVE program for a resource. Group discussion on Mentors.</p>	All Members
