Discussion

- 2 applications removed from consideration
 - Watch Me Grow Ineligible due to open investigation with Health & Welfare
 - Immersivo Learning Systems Withdrew application
- Ms. Allen proposed reviewing applicants by:
 - By ranking of overall score
 - Highest is 23
 - Look at 19 23 (total just over \$3M)
 - Eliminate 11, 12, & 14 due to low scores
 - Balance would be approximately \$84K
 - Discussion:
 - Note: How much confidence does the Committee have in the applications with scores of 16 & 17?
 - Would the Committee reconvene if someone withdraws?
 - If de-obligation is necessary, yes
 - Applicants must be under contract by September 30th
 - Re-obligation would need to be done immediately to allow for review by the Executive Committee
 - Some hesitation about funding those with scores in the mid-teens, perhaps a large provider who was partially funded would be better served with the balance
 - If the Committee intends to consider funding an application with a score of 16, all those with that score should be evaluated
 - Current applicant list is 16 new providers and 10 expanding
 - New applicants are surmising on budget costs; existing providers provide real data based on experience which may cause the score to be higher for the new applicant
 - Example: Mountain Sky Daycare is an existing provider and scored lower than 2 applicants that are new providers
 - Complaint History 5 with histories
 - Substantiated
 - Cassandra Hleovas Child Care Supervision, imminent danger

- Little Bug's Daycare Inc Operating without license, significantly unclean
- Unsubstantiated
 - Acuarela LLC rodent droppings
 - Our Future Society LLC minors in charge
 - Magic Stars Spanish Preschool ratio concerns
- Pull both applicants with substantiated complaints
- Project Readiness review the "no's"
 - Ashley's Daycare & Montessori

 does not have financing to do construction, familyowned property, application was extensive, did not work with Wonderschool, lots of
 experience, Montessori, has a conditional use permit approved
 - Gem Kids Infant & Toddler Center no property identified, knows property manager, if approved, staff would request to see at least a 3 year lease, high score, strong partner
 - Creative Corner Learning Center no interim funding in place for initial project, if approved, staff would recommend no reimbursement until approved loan is in place
 - Mountain Sky Daycare lack of property identified, currently working extensive hours, concern about time to complete project if awarded
- 2 Applicants with Scores of 16 or 17 remain

Motion by Mr. Balben to obligate funding to the following Small Provider Applicants and recommend approval to the Executive Committee: Acuarela LLC \$120,000, Apples and Oranges Daycare \$90,000, Armbruster-Kids Family Daycare \$138,547, Ashley's Daycare & Montessori \$152,665, Baraka Childcare \$60,000, Bilingual Adventures Academy \$180,000, Creative Corner Learning Center LLC \$180,000, Ducks in A Row Daycare \$180,000, Gem Kids Infant and Toddler Center LLC \$180,000, Huckleberry Montessori \$176,635, Jabbers LLC \$180,000, Jellybean's Playcare Center \$179,957, Land of the Littles \$179,999, Lilypad Childcare LLC \$160,000, Magic Stars Spanish Preschool \$180,000, Mountain Sky Daycare \$126,725, Our Future Society LLC \$177,100, Treasure Valey Waldorf LLC DBA Wildflowers \$180,000.
