5. Roundtable Reports	Whitney – Not a whole lot. Shannon – There are cases that are pending. One is committed. There are 45, this includes pending and probation cases. Harold asked what has been trending. She replied that possession and paraphernalia w/ marijuana. Also, some battery cases, concerning fights at schools. Tara – SWDH sub grantees doing preventative work. Strengthening Families Program will be taking place in Canyon County through Insight Matters. SWDH continues partnership with the Marsing School District to implement the Communities for Youth Model. The school recently conducted their youth wellbeing survey and will be reviewing the data after it's analyzed. Exploring potential partners to implement the Communities for Youth Model in the next couple of years, and are in discussions with NSD. Savannah – January 1st YouthRoc will go from four community providers to two this is due to funding. The plan is to strengthen those two providers. YouthRoc will be completing funding requests at the next legislative session. Linda asked if it will cause a waitlist given the loss of providers. Savannah said we will see some availability, numbers have gone down since last year so that's why funding went down. Harold asked are they coming from all the counties in D3. Savannah replied that the majority of referrals come from Canyon County. Dahlia – Case numbers are low, not a lot of action. Petty theft or battery have been the majority of the caseload. No referrals from the schools. Working on distributing opioid funds. Linda – Couple of positions opened at Juvenile Probation in Canyon County. Has POST coming up in January. Harold asked if drug trends are still in high potency marijuana, all JPO's said that is the only marijuana they are seeing. Harold asked if that would be a potential speaker training opportunity. Linda stated at IJJA there is already training offered for drug and alcohol use. Dahlia said that it would not be something she would want to spend on because JPOs have resources and access to those trainings within their departments already. Harold – Working on getting set up for Day 4 RJ Training for COSSA. Oster – CWI growing science center. Enrollment is at 33,000 students right now.	All Members
