- Labor:
 - If you want to attend regional One-Stop meetings, now is the time to get those on your schedule.
 - Guidance for American Job Center partners was issued yesterday; Mr. Hanchett will present info on it next week.
- Easter Seals-Goodwill:
 - \circ $\;$ There are room for enrollments in the Easterseals-Goodwill programs.
 - Presentations with workforce partners around the state are being offered to raise awareness and opportunities for people in other programs to co-enroll. If folks are interested in a presentation, they can reach out to Deb or Sharon Kierulf.
- Vocational Rehab
