The Birch Creek Water District 32-D Water Users meeting was held March 4, 2025, 10:00 a.m. at the Clark County Annex Building, Dubois, Idaho, for the purpose of electing a Watermaster, Chairman and Secretary, and transacting such other business that might come before the meeting pertaining to the irrigation water of the district.

Andy Wagoner called the meeting to order at 10:09 a.m.

Those attending were Andy Wagoner (Chairman), Heath Wagoner, Paul Webster, Casey Palmer, Greg Shenton (Watermaster), Brett Murdock (Deputy Watermaster), and Laurie Small (secretary).

Minutes were read individually. **Paul Webster made a motion to accept the previous year's minutes. Heath Wagoner seconded the motion. Motion passed.**

NOMINATIONS FOR CHAIRMAN & SECRETARY

Mr. Wagoner asked for nominations for chairman and secretary. **Paul Webster moved to have Andy Wagoner as chairman and Laurie Small as secretary. Casey Palmer seconded the motion. Nominations passed.**

APPOINTMENT OF CREDENTIALS COMMITTEE

Chairman, Andy Wagoner, waived appointing a credentials committee at this time. If one is needed, they can be appointed at that time.

WATERMASTER'S REPORT

Mr. Shenton presented the Watermaster's report for 2024. The 2024 diverted flows totaled 15,706, A.F., down 1,696 A.F. from 2023 flows. A chart with the yearly delivery in acre feet for the past 15 years was included in the report. Measurements of stream bed losses taken by contract with U.S.G.S between the reaches of Blue Dome to the Birch Creek Power Hydro Pond were included in the report. The weir on both ends of this reach gives the Watermaster a very accurate measurement of the total reach if the weirs are properly maintained along with annual silt removal. The advantage of a weir is the fact that at any time you read it you get accurate and immediate flows.

Snow course measurements were 100% of average at Meadow Lake with 43" of depth and 11.6" water content, 90% of average at Beagle Springs with 28" of depth and 6.5" water content, 85% of average at Haun with 27" of depth and 4.1" water content and 58% of average at Spring Mountain with 30.2" of depth 6.6" water content. Snow measurements were taken on February 25, 2025. The Haun and Spring Mountain sites are based on a twenty-four-year average. The Haun average is 4.8 inches of water. The Spring Canyon average is 10.24 inches of water. Beagle Springs 30-year average is 6.3 inches. Meadow Lake's 30-year average is 11.3. Snotel data was acquired on February 28, 2025. Monthly flow totals were in the report. average. The Haun average is 4.8 inches of water

Cloud seeding continues with both the remote and manual generators. The manual generators budget is \$312,000.00 this year to operate and Idaho Power controls and pays for the remote generators. The Water Resource Board contributed \$60,000.00 to the cloud seeding program. An additional \$40,000 will be requested next year to bring the budget to \$100,000. The USBR map was handed out that shows the generator's placement and flight patterns. The water district can budget funds towards cloud seeding if they choose to. Mr. Wagoner mentioned he didn't think the placement of the generators were benefiting the Birch Creek area.

The Wagoner's weir needs to be replaced this year. There have been improvements made to it, but replacement is necessary. Mr. Wagoner said they planned on putting in a new metal weir. Mr. Shenton suggested keeping it in the same location. It was determined the existing weir was put in May of 1995.

The Watermaster reported \$230.00 remains in the district's checking account. Mr. Shenton informed the water users that they could close the checking account, move the funds to the district's budget and use it as needed. After discussion, the money will remain in the checking account.

Mr. Shenton reviewed the 2024 budget and proposed 2025 budget.

Paul Webster made a motion to approve the proposed budget. Casey Palmer seconded. Motion passed.
