<b>Discussion:</b> 3 Year Plan Work	The council discussed three training efforts that will be pursued in the upcoming months.  They are as follows:  1) DSO Training for Region 6 – Stace said that he would continue to coordinate with relevant parties to find a time that will be feasible. It will be critical that all judges are available for the training. Due to that requirement, the training could be scheduled up to 6+ months out.	All Members	
	2) TBRI Training for Region 6 – Shannon will reach out to Racheal and begin discussing the idea/resources needed to host a training for Region 6.		
	3) Educational Crisis Conversations – Stace discussed that he would be able to talk with Matt Hardin from Magellan to see if a short and virtual training could be provided to community members and professionals throughout Region 6.
