Updates	Commission/ Committee Chairs	<ul style="list-style-type: none"> - Chair - Program: April was not able to attend the last committee meeting. They did not have a quorum. The committee reviewed standard operating procedures. The committee will have four applications to review. - Governance: Kimber said they spent time on having a consistent operating procedures for elections. Worked on clarity on the expectations from the Governor's office. - Member Support: Emily said they reduced the amount in member assistance fund to around \$15,000 with match. - Executive Director: Char, Angela and Emily went to DC to meet with other commissioners. They had chance to hear from the director of AmeriCorps. The focus will be on America 250 to commemorate the country's 250th birthday. AmeriCorps will change to AmericaFirst Corps. AmeriCorps is flagged as high fraud agency so that is a concern. Government shutdown is also a concern, but AmeriCorps members will continue to serve and programs will continue to function. Kimber and April said they would be willing to help if there are things that come up or if programs need added support. The executive order expires later in October, so we will need to contact the Governor's office. Kimber recommended contacting the Governor's office at the beginning of new year with the new leadership of the commission in place. Emily announced that Serve Idaho is hiring a new financial assistant temp in the Boise office.
