### **Background:**

Summary of Proposed Rulemaking Language:

Based on the attached documents, the OSMB is considering a new rule to address guide reciprocity on the Snake River, which forms part of the Oregon/Idaho border. Currently, Oregon does not restrict Idaho-licensed guides from operating on the Oregon side of the Snake River. The existing description asserts that Idaho restricts Oregon licensed guides from operating on the Idaho side; however, Idaho does not currently place such restrictions on Oregon licensed guides. Oregon agencies and the Guide Advisory Committee are recommending creating consistent reciprocity rules like those already in place on the Columbia River between Oregon and Washington. The proposed rule would require Idaho outfitters and guides to be registered in Oregon to launch, pick up, or drop off clients on Oregon soil along the Snake River. This aims to eliminate enforcement challenges and ensure consistent regulatory treatment between border shared rivers.

Proposed Rule Summary (OAR 250-016-0088)

*The rule would establish reciprocity provisions allowing Idaho-licensed guides to operate on the Snake River only for carrying passengers for hire, not for launching or discharging clients on Oregon soil unless they register in Oregon. It aligns Snake River regulations with existing Columbia River reciprocity rules and helps prevent confusion about exact boundary locations on the river.*
