Following discussion, Mr. Lanzet amended the motion to specify that doctoral candidates who have faculty status for students currently enrolled in a counseling program may act as supervisors. It was seconded by Ms. Kammer. Motioned carried.

Ms. Lawler presented a legislative update. She informed the Board that the following bills passed the 2022 Legislative Session: House Bill 654, Senate Bill 1296, House Bill 612, Senate Bill 1244, House Bill 629, and Senate Bill 1297
