Welcome, Introductions, Ground Rules, and Perfection of Agenda

Danielle "DR" Reff, Council Chair, called the meeting to order at 9:04 AM.

Guests were welcomed and guidelines were reviewed.

Danielle "DR" Reff, Council Chair, reviewed the ground rules for meeting protocol.

Christine Pisani included a request for input from the Council regarding a formal complaint Idaho has sent to the Board Members of the National Association of Councils on Developmental Disabilities (NACDD.) The complaint was reviewed with the Council. Council Members provided support for additional funds needed to ensure needed accommodations are met. Jenna Garrett shared a concern that there are likely many other Members from other Councils that are discouraged from attending the annual NACDD conference due to language access needs not being met. She suggested that the Idaho Council work with other Councils to push this issue, because it cannot only be affecting Idaho. Maria Juarez shared her appreciation of the support the Council has shown. She wants to talk to other Council Executive Directors during the conference to share the impact this issue has on non-English speaking conference attendees.

Presentation: Quarterly Project Reports – Marieke Edwards, Research Analyst

Activities for each State Plan Goal were presented by staff for the past quarter (April 1-June 30, 2023); however, background information was shared to assist

new Council Members with understanding projects. Project activity reports included detail on Community NOW!, *Lideramos Juntos*, ("Together We Lead," Spanish Partners in Policymaking), the Disability Advocacy Network of Idaho (DANI), and the development of a Community of Practice on Person Centered Practices.

Marieke Edwards presented the financial report. She helped answer questions about state and federal financial timelines and how they affect Council spending. She also reviewed how money is set aside to support each of our State Plan goals. Marieke helped Members understand how carry over funds from past federal appropriations have impacted our spending and planning for 2024.

Minutes

Welcome, Introductions, and Review of Ground Rules

Danielle "DR" Reff, Council Chair, called the meeting to order at 9:06 AM.

Guests were welcomed and guidelines were reviewed.

Danielle "DR" Reff, Council Chair, reviewed the ground rules for meeting protocol.

Presentation: Membership Update - Jill Smith, Program Specialist

Jill Smith shared updates regarding the New Member appointment process and rating tool. Jill reviewed the Council Member Roster that outlined terms, contact information, and timeline for reapplication and/or reappointment for all Members. Members were updated on recruitment efforts planned between now and March 2024 with the goal for Members to assist with recruitment in their local communities.

Presentation: Idaho Anti-Human Trafficking Coalition Report – Jennifer Zielinski, Executive Director, Idaho Anti-Human Trafficking Coalition

Jennifer Zielinski and Monica Martinez shared outcomes and recommendations from the report the Council funded in 2023. The Coalition is the only organization attempting to collect data on persons with disabilities who are victims of human trafficking. A primary recommendation in the report is focused on the lack of identification of victims with a disability. There is a great need to work with many levels of stakeholders to improve how victims are identified to ensure victims are able to make reports in a variety of ways and receive communication supports in the event their disability makes verbal reporting difficult or impossible.

Member Reports – Jennifer Johnson, Maria Juarez, Nicholas Wyatt, and Rochelle Larsen

Nicholas Wyatt presented his activities over the last quarter that included his participation in Person-Centered Thinking training, his work experience with LINC, and that he is exploring running for public office. Maria Juarez shared her work helping to organize the June Burley Conference. Other work included participating on the Quality Assurance Workgroup for the Living Well grant. She thanked the Council for its support to make the Burley conference a success. Rochelle Larsen shared that she worked on recruiting potential Council Members and is participating in the Leadership Development event coming to Southeast Idaho this Fall. Jennifer Johnson shared her activities with her community board seats and recent travel opportunities. Jennifer also shared an update on her experiences with the Youth Empowerment Services (YES Program) to help Council Members understand more about what the YES Program is like to work with and how it has impacted the providers she is trying to access for her family member.

Maria, Edgar and Marilu shared their presentation about their leadership journey for the National Association of Councils on Developmental Disabilities (NACDD) conference occurring in Florida next week. They will be presenting in Spanish with English translation.

 - Immediate relatives or guardians of adults with impairing developmental disabilities who cannot advocate for themselves."
