XIII. Agency Initiatives/Projects – Informational Only

- Community Transportation Association of Idaho (T. Lindenberg) Took the summer off. Future direction of CTAI. Previously CTAI was involved in the ITD Summit. As a group, we are interested in collaborating with ITD-PT on the Summit.
- Idaho Commission on Aging (J. Miller) We are working on a consumer directed/volunteer transportation program. Piloting in Areas 1 and 3. Still working on funding issues. Will be able to reach rural areas that have been unserved in the past.
- Idaho Department of Education (A. Stolzman) Working on an electric bus memorandum. Submitted budget request for spring legislation on increasing transportation support program reimbursable costs to school districts.
- Idaho Department of Health & Welfare, Division of Medicaid (D. Mallory) implementing our new NEMT contract. Adjustments in new contract. More boots on the ground in terms of personnel that can aid in assisting with logistics. About 160,000 trip requests last month. Long distance trips need to be requested 10 calendars in advance. Working on process for expanding what is a long distance trip. Mileage reimbursement for simple requests is now available through an app request. Requests for unaccompanied minors are being reviewed by the Department now the contractor.
- Idaho Department of Labor (T. Gammel) We continue to provide the services through existing funding. Continue to look for additional funding opportunities to continue our efforts.
- Idaho Workforce Development Council (A. Ames) Quarterly council meeting last week about
 workforce and employer needs. We've been having conversations with NEVI group for
 workforce training for electricians. LAUNCH program is gearing up for 2024 graduates and
 adult training.

- Office of the Governor (K. Staskey) Bobbi Jo will be leaving for the Boise Chamber of Commerce.
- Idaho Department of Environmental Quality (M. Anderson) Working on the Climate Pollution Reduction Grant. Planning grant right now that we are developing and identifying an action plan targeted to reducing greenhouse gases. Gem State Air Quality Initiative. Kickoff meeting is October 19. For the priority plan, due in March, if a measure is identified in that plan there is \$4.6 billion available in competitive and implementation grant. Transportation is a key area that we are looking at.
- Idaho Veterans Services (K. Wallior) no updates at this time
- Nez Perce Tribe (W. Holt) Highway 95 project, 2 year duration, underway. Still operating
 with full service, but short on staff. New FMCSA requirements for ELDT is making it more
 difficult to get drivers. New Office Specialist II.
