The discussion during our last meeting was very productive. I appreciate the ground water users' efforts to prepare a draft for circulation and review by the committee members. I look forward to discussing the edits, comments, and proposals from the committee.

As you are aware, there are ongoing negotiations between the Surface Water Coalition (SWC) members and the Idaho Ground Water Appropriators to find a long-term settlement of the SWC delivery call. If a settlement is reached, the terms of settlement might influence certain sections of the management plan. Although it is important for us to continue forward with our committee meetings, Lieutenant Governor Bedke asked if I would be willing move our next meeting to August 20th to allow the parties to the settlement negotiations some time to focus on those issues before turning their attention back to the management plan. Recognizing that these two parallel processes have some overlapping issues, I agreed to make that adjustment to our meeting schedule.


